\* PWAM is the investment manager to PWIMF and Park West Partners International, Limited, a Cayman Islands exempted company (“PWPI”, and together with PWIMF, the “PW Funds”). Mr. Park, through one or more affiliated entities, is the controlling manager of PWAM.

As of September 30, 2024, PWIMF held 318,934 shares of Common Stock; warrants (“Warrants”) to purchase up to 531,522 shares of Common Stock; and convertible senior notes (“Notes”) of up to 1,277,193 shares of Common Stock issuable following conversion. PWPI held 31,066 shares of Common Stock; Warrants to purchase up to 68,583 shares of Common Stock; and Notes of up to 126,315 shares of Common Stock issuable following conversion. The Warrants are currently exercisable within 60 days of this report. As a result, PWAM and Mr. Park are deemed to beneficially own the shares of Common Stock underlying the Warrants. As of September 30, 2024, PWAM and Mr. Park may be deemed to beneficially own 2,353,613 shares of Common Stock of the Issuer held in the aggregate by the PW Funds.

The reported beneficial ownership percentage is based upon approximately 63,613,798 shares of Common Stock issued and outstanding as of August 13, 2024, based on information included in the Quarterly Report on Form 10-Q filed by the Issuer on August 14, 2024.
